

## A LEVEL

Students seeking an A level grade for the first time in Summer 2024, having sat AS units in 2023, will receive a grade based on the total uniform marks achieved in all AS and A2 units.

### Example 1 – A Level Provisional Statement of Results

## A LEVEL RESITS

For students resitting an A level in Summer 2024, having sat AS units in 2022, the following applies:

- If at AS level you completed only the mandatory unit(s), you will receive an A level grade based on the uniform marks achieved in the mandatory AS unit(s) combined with all A2 units.
- If you completed all AS units in 2022, or across 2022 and 2023, you will receive an A level grade based on the uniform marks achieved in either:
  - a) all AS units and all A2 units; or
  - b) the mandatory AS unit(s) and all A2 units – whichever is higher.

### A note on unit and qualification marks for students resitting A levels

If you notice that your **Final Uniform Marks** don't match the total **Uniform Marks** you achieved in your units, don't worry! It's because all students resitting A level qualifications in Summer 2024 will be graded out of the **maximum** uniform marks total in each qualification.

For example, if your best performance represents 70% of the uniform marks available in your completed unit(s), this will be converted to 70% of the maximum available for your overall qualification.

Examples 2 and 3 are for A Level History, where AS Unit 1 (SHY1) was the mandatory unit in 2022.

## Example 2 – Provisional Statement of Results (Students Resitting A Level)

Please note: the student entered A2 Unit 2 (AHY2) for a second time in Summer 2024, scoring 65 uniform marks, which was a higher uniform mark score than their original performance in Summer 2023. The higher uniform mark was counted towards their final grade.

All units	$35 + 40 + 41 + 65 = 181/300$ uniform marks (60.3%)	60.3% of total uniform mark of 300 = 181.00	Grade C	✓
Mandatory AS + all A2 units	(35 scales to) $70 + 41 + 65 = 176/300$ uniform marks (58.7%)	58.7% of total uniform mark of 300 = 176.00	Grade D	✗

## A LEVEL RESITS (continued)

### Example 3 – Provisional Statement of Results (Students Resitting A Level)

Please note: the student entered the optional AS Unit 2 (SHY2) in Summer 2022, scoring 31 uniform marks. This was not counted towards their final grade, as their performance in only the mandatory unit AS Unit 1 (SHY1) resulted in a higher uniform mark total.

The student also entered A2 Unit 1 (AHY1) for a second time in Summer 2024, scoring 57 uniform marks, which was a higher uniform mark score than their original performance in Summer 2023. This was counted towards their final grade.
